Sir,

I am to invite a reference to item 11 of Annexure A
to this office circular No. 78 dated 6th October, 1960, and to add
that in view of the directions already issued by the Board of
Revenue, if preparation of a quadrennial Register Hagdaran
according to roster is postponed, the preparation of the
zamindar thereof should not be postponed and that a copy
containing existing upto date entries should be supplied
Union Councils. But it has been observed that there will be
preparing such copies of the Register Hagdaran Zamin. This use
was referred to the Board of Revenue who have agreed with
suggestion and directed that in future instead of prepar
zamindar of Register Hagdaran Zamin which according to ro
