NOTIFICATION

No.2109-2019/756-CL(IV). In exercise of the powers conferred under section 10 of the Colonization of Government Lands (Punjab) Act, 1912 (*V of 1912*) and in partial modification of Punjab Government Notification No.549-2013/239-CL(I), dated 05.03.2013, Governor of the Punjab is pleased to make the following amendment in Lease of certain available State land for landless Cholistanies under Temporary Cultivation Lease Scheme with immediate effect:

AMENDMENT

In **the Notification No.549-2013/239-CL(I), dated 05.03.2013**, for clause 9, the following shall be substituted:

"9) Applications, composition of scrutiny committees and balloting for allotment of the Stand land.- (1) Fresh applications shall be invited by the Cholistan Development Authority, Bahawalpur within ninety days. Previously submitted applications shall not be considerable.

(2) Seven following scrutiny committees i.e. four committees for Bahawalpur District, two committees for Rahim Yar Khan District and one committee for Bahawalnagar District may be constituted as hereunder:

(3) The balloting for allotment of State land under temporary cultivation lease scheme shall be conducted digitally by Punjab Information Technology Board, Lahore to ensure transparency in the allotment process.

(4) The list of eligible candidates and details of lots included in balloting process shall be displayed in the office of the Cholistan Development Authority, Bahawalpur before seven days of the balloting for information of general public.

(5) Grievance redressal committees headed by the retired District and Sessions Judges shall be notified for each aforementioned district."
