CORRECTION SLIP NC. 1-2001/LRM Dated 9 - 01-2001.

In paragraph 7.14 for sub-para 5 the following shall be substituted namely:-

(5) Column 8 & 9 _____ " If a co-sharer in a joint holding transfers by sale, mortgage, gift exchange or otherwise the whole or a fraction of his/her share, the name of the transferee will be shown in column No.8 of register Dakhil Kharij where as if he/she transfers an area of certain specific Khasra Numbers in his/her 'Hissadari' possession, the transferee's name should also be shown in column No.9 of Register Dakhil Kharij and a brief explanation of his occupancy be noted in column No.14(remarks)".

CORRECTION SLIP NC.2-2001/LRM Dated 02-01-2001

In paragraph 7.41 in sub-paragraph(5), for clause No. (vi) the following shall be substituted, namely:-


(iv) "if a Co-sharer in a joint holding transfers an area of certain Khasra numbers in his 'Hissadari' possession, the name of the transferee should be shown in column No.4 as well as in column No.3".
