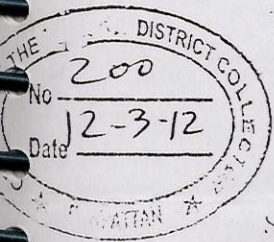

Subject: THE PUNJAB CONFERMENT OF PROPRIETARY RIGHTS ON OCCUPANCY TENANTS AND MUQARRARIDARS ACT, 2012

A copy of the Punjab Conferment of Proprietary Rights on Occupancy Tenants and Muqarraridars Act, 2012 (XXVII of 2012) published in the Punjab Gazette, Extraordinary dated February 11, 2012 is enclosed.

2. Under the said Act, all occupancy tenants under any section in Chapter II of the Punjab Tenancy Act, 1887 (XVI of 1887) and Muqarraridars have become owners without payment of any compensation of the land in their occupation according to the revenue record. The Act also requires that the Revenue Officer shall enter in the revenue record the name of the occupancy tenant or the Muqarraridar as the owner of the land.

3. You are therefore requested to ensure that mutations of ownership rights are entered and sanctioned immediately in favour of all persons shown in the revenue record, under column of cultivator, as occupancy tenants under any section (namely section 5, or section 6 or section 8 or section 11) falling under Chapter II of the Punjab Tenancy Act, 1887, or as Muqarraridars. Entries under column of ownership, column of cultivator and column of rent in Registers Haqdaran Zamin, for rural and urban lands, shall be changed through mutations in accordance with the provisions of the Punjab Conferment of Proprietary Rights on Occupancy Tenants and Muqarraridars Act, 2012. All such mutations should be sanctioned within a period of 3 months without fail.

4. After three months, a compliance report should be submitted by the District Collector to the Board of Revenue, Punjab confirming that mutations as required vide paras 2 and 3 above have been sanctioned by the Revenue Officers in all cases.
