In pursuance of the provisions contained in sections 3,4 and 5 of the Punjab Government Land and Buildings (Recovery of Possession) Ordinance, 1966 (West Pakistan Ordinance No.IX of 1966) and in supersession of notification No.WG-3-50/62, dated 20.08.1966 of the Communication and Works Department, West Pakistan, the Governor of the Punjab is pleased to authorize the Estate Officer to the Government of the Punjab, Lahore, within his jurisdiction:-

- (a) to enter upon the Government land or buildings which, the lessee, license, or un-authorized occupant, and the case may be, has failed or refused to vacate;
- (b) to recover vacant possession by evicting the lessee, license or un-authorized occupant, and the case may be; and
- (c) to demolish or remove, if necessary, the structure, if any, erected or built thereon by the lessee, license or un-authorized occupant.
