-LR-II. The Board of Revenue Punjab is please to make the following amendments in Chapter 7 of the Punjab Land Records Manual (Second Edition):-

Correct Slip No. 5 L.R.M. dated 18th June, 2014

1. In para 7.28, entry (a) under clause (ii) and entry (b) under clause (iii) shall be omitted.

2. After para 7.28, the following para 7.28-A shall be inserted:

"7.28-A. Cases where Dakhil Kharij are necessary regarding change of name or the father's name:- (1) Where the name of right / interest holder or the father's name appearing under column 3 or column 4 of latest Register Haqdarar Zamin against one or more Khewats / Khatunis or in other revenue record has been legally changed i.e. the name recorded in Register Haqdarar Zamin / other revenue record does not tally with the name given in Computerized National Identity Card, the person concerned may make an application to the Tehsildar concerned stating facts and requesting for change of name in the Register Haqdarar Zamin / other revenue record.

(2) On receipt of application under sub-para (1), the Tehsildar shall obtain report in the matter from the revenue field staff i.e. Patwari Halqa, field Kanungo and Circle Revenue Officer concerned. Before sending the reports of Patwari and Kanungo to the Tehsildar, the Circle Revenue Officer shall record the statements of at least two respectable persons, preferably Lambardars or members of the Local Government in respect of the genuineness of the request for change of name and obtain their signatures / thumb impressions on the report, giving also numbers of their Computerized National Identity Cards. Where the Tehsildar himself is Circle Revenue Officer, he shall take similar action. Thereafter, the Tehsildar shall pass necessary order on the report, after affording an opportunity of hearing to the applicant where his request is to be rejected.

(3) The Tehsildar shall decide the application within fifteen days from the date of its receipt.

(4) After passing of order by the Tehsildar in favour of the applicant, further action shall be taken as under:

(i) In case the revenue record of the estate has not yet been computerized, the order of Tehsildar passed in favour of the applicant shall be communicated to the Circle Revenue Officer concerned for entry and attestation of mutation. The Circle Revenue Officer shall decide the mutation within seven days of the receipt of order of the Tehsildar.

(ii) In case the revenue record of the estate has been computerized and the same is operational at the Service Centre of Tehsil, the order shall be communicated to the Service Centre, alongwith photocopy of the application and report on which the order was passed. On receipt at the Service Centre the order, application and report shall be saved in the system and computerized mutation shall be entered on the date of receipt of order and the Service Centre Revenue Officer shall sanction the mutation using his electronic signatures.

(iii) No mutation fee shall be charged in such cases.

No.2441-2016/1103 LR-II. The Board of Revenue, Punjab is pleased to make the following amendments in Chapter 7 of the Punjab Land Records Manual (Second Edition):-

Correction Slip No. 08 -- L.R.M., dated 09 December, 2016.

In paragraph 7.28-A-

(1) for sub-paragraph (4), the following shall be substituted:

"(4) After passing of order by the Tehsildar in favour of the applicant, mutation shall be entered by the Patwari and decided by the Circle Revenue Officer within seven days of the receipt of order of the Tehsildar."; and

(2) after sub-paragraph (4) substituted as aforesaid, the following sub-paragraphs (5) and (6) shall be added :

"(5) The correction of name may be made in the revenue record at Arazi Record Centre by the Assistant Director Land Records with powers of Assistant Collector First Grade on the basis of following documents.

- (i) In case of citizen of Pakistan of the age of eighteen years or above, his original Computerized National Identity Card.
- (ii) In case of citizen of Pakistan below the age of eighteen years, the original Computerized Identity Card of his guardian and Form B of the minor.
- (iii) Biometric verification of the particulars from the NADRA.
- (iv) An affidavit with the confirmation of correction of name and / or father's name. In case affidavit is found false all entries made in the revenue record will be reversed and criminal proceeding will be initiated against the individual.
- (v) Evidence of Lambardar, Local Government representative, Pattidar, Shareek Khata especially in case of caste, sub-caste.

(6) No mutation fee shall be charged in such cases."
