

PUNJAB LAND COMMISSION

NOTIFICATION.

Lahore, dated the 29th April, 1972.

No. OS-279/72/1380-LC(II). In exercise of the powers vested in it under paragraph 4(5) of the Land Reforms Regulation 115 of 1972, read with the provisions of paragraph 32 of the Regulation *ibid*, the Punjab Land Commission is pleased to order that the Punjab Land Commission constituted under Land Reforms Regulation 115 of 1972 is the legal successor of the defunct Punjab Land Commission, which operated under the repealed Regulation 64 of 1959. As such the newly constituted Land Commission, has taken over all assets and liabilities of the defunct Punjab Land Commission. It has been further decided that all the balances and other assets and liabilities of the defunct Land Commission shall stand transferred to the newly constituted Punjab Land Commission. The Chief Land Commissioner, Punjab/Secretary Punjab Land Commission shall continue to operate Land Commission funds in accordance with all the powers delegated to them and other orders and provisions of the Punjab Land Commission.
