In exercise of the powers conferred by paragraph 12 of the Land Reforms Regulation, 1972 (Martial Law Regulation 115) and all other powers enabling it in this behalf, the Land Commission of the Punjab is pleased to direct that any person who at any time after the 20th Day of December, 1971, and before the issue of this Notification, in any manner whatsoever has come to own or possess any area of land in excess of the area permitted under Part III of the said Regulation shall file on or before 31st August, 1973, declarations in Forms LR-I-A and LR-II-A, in the manner prescribed in the said forms.
