In exercise of the powers conferred on it under paragraph 4(2) of Martial Law Regulation 115, as amended, the Punjab Land Commission, with the previous approval of the President, is pleased to direct that for purposes of application of paragraph 8 of the aforesaid Regulation in the future as well, the calculation of Produce Index Units shall be made on the basis of classification of soil as entered in the revenue records for Kharif 1969 and Rabi 1969-70. In case there is difference of Produce Index Units in the two harvests, the harvest carrying higher Produce Index Units shall prevail.
