Subject:- ENHANCEMENT OF MONETARY LIMITS OF JUDICIAL
AND NON-JUDICIAL STAMPS HELD IN TREASURERS
CUSTODY AND DEPOSIT OF SECURITY BY THE
TREASURERS/ASSISTANT TREASURERS/SUB-TREASURERS.

Sir,

I am directed to state that the question of revising the monetary limits of Judicial and Non-Judicial stamps to be held in the sole custody of the Treasurers as laid down in Rule 3.5(i) of PFR Vol.I has been examined in consultation with Board of Revenue. These limits were fixed long ago.

2. It has been decided to fix monetary limits of Judicial and Non-Judicial stamps, to be held in the sole custody of the Treasurers in the single locks as stated here under:-

	<u>STATION</u>	<u>LIMIT.</u>
1.	Lahore	Rs.50,000/-
2.	All Divisional Headquarters except Lahore.	Rs.35,000/-
3.	All other District Headquarters.	Rs.25,000/-

3. It has been further decided that the limits of cash and personal securities to be furnished by the Treasurers, Assistant Treasurers and Sub-Treasurers shall be as under:-

	<u>STATION</u>	<u>CASH SECURITY</u>	<u>PERSONAL SECURITY.</u>
1.	Lahore	Rs.20,000/-	Rs.50,000/-
2.	All Divisional Headquarters except Lahore	Rs.14,000/-	Rs.50,000/-
3.	All other District Headquarters.	Rs.10,000/-	Rs.50,000/-

4. Sub-Treasurers Rs. 5,000/- Rs.50,000/-
working in the
Sub-Treasuries.

4. The above orders would take effect from,
1st October, 1986.

5. However, the Commissioner may in their
discretion further enhance the amount of personal
security if and when considered necessary according to
local circumstances. Necessary amendment in the Rules
is being made by the Finance Department.
