CHARGING OF REGISTRATION FEE IN RESPECT OF  
REDEMPTION DEEDS.

MEMORANDUM:-

In continuation of this office Notification No.1487-2003/693-ST(I), dated 23.6.2003 and modified Notification No.130-2004/38-ST(I), dated 1.1.2004, on the subject noted above.

2. Through the Notification No.1487-2003/698-ST(I), dated 23.6.2003, the rate of Registration Fee in respect of simple/legal mortgage with the Banking Companies was reduced from 1% to 0.25% on the Mortgage money. The said Notification was modified vide Notification No.130-2004/38-ST(I), dated 1.1.2004 and the rates of Registration Fee were fixed for the Mortgage Deeds with Banking Companies and Mortgage for Housing Finance(copies enclosed).

3. The rates of Registration Fee on Mortgage Deeds and Redemption Deeds were clearly mentioned in the above said Notification irrespective of the fact to which period it relates.

4. You are requested to direct the Sub Registrars concerned, to charge the rates of Registration Fee for Mortgage/Redemption Deeds, according to the above said Notifications.
