The Project Implementation Unit, Punjab Urban Land Systems Enhancement (PULSE) Project, Govt. of Punjab has received financing from the World Bank toward the cost of the Punjab Urban Land Systems Enhancement (PULSE) Project, and intends to apply part of the proceeds toward payments under the contract for Hiring of Services for the Digitization of Mauzas for 03 Divisions of Punjab.
2. The Project Implementation Unit, PULSE, Govt. of Punjab now invites sealed Bids from eligible Bidders for Hiring of Services for the Digitization of Mauzas for 03 Divisions of Punjab.

Bidding will be conducted through International competitive procurement using a Request for Bids (RFB), “Single Stage One Envelope” procedure, as specified in the World Bank’s “Procurement Regulations for IPF Borrowers dated November, 2020, and is open to all eligible Bidders as defined in the Procurement Regulations.

6. Bids must be delivered to the address below on or before **29th March, 2023 at 12:30PM**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly

opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **29th March, 2023** immediately after bid submission deadline.

7. All Bids must be accompanied by a Bid Security against each lot in the following manner:

Lot 1: Data Entry Services for Gujranwala Division – PKR 3,390,000/- or USD 15,000/-

Lot 2: Data Entry Services for Gujrat Division – PKR 1,220,000/- or USD 5,400/-

Lot 3: Data Entry Services for Rawalpindi Division – PKR 4,070,000 or USD 18,000/-
